### WHY EDUCATION SUPPORT

### WORKPLACE TRAINING

Within this course, there is a mandatory work placement requirement of a minimum of 100 hours, enabling you to graduate highly skilled and confident. Placement must be completed in an Australian regulated work place. Students will be required to complete assessment tasks whilst in the workplace.

### COURSE DURATION

12 months, however students have the flexibility to take up to 18 months to complete the qualification.

### ENROL NOW, START ANYTIME

This qualification reflects the role of workers in a range of education settings who provide support to teachers and students in the classroom environment. These settings could be public or independent schools and/or community education settings. Throughout this course, students will learn the skills and knowledge required to provide assistance and support to teachers and students whilst under broad-based supervision.

### POSSIBLE JOB ROLES INCLUDE

This course will provide you with skills and knowledge to pursue possible career pathways such as:

- ⇒ **Education Assistant**
- ⇒ **Literacy Worker**

# CERTIFICATE 3 GUARANTEE FUNDING

## ***COST***

This training is funded under the Queensland Government's Certificate 3 Guarantee program for eligible participants.

Eligibility:

- Permanent Queensland Resident,
- Aged 15 years or over,
- No longer at school,
- Australian or New Zealand Citizen, or Australian permanent resident (including humanitarian entrants, or a temporary resident with the necessary visa and work permits on the pathway to permanent residency),
- Must not have completed or be enrolled in a qualification at the same, or higher qualification level of the course you are applying for, not including qualifications completed at school and foundations skills training.

A co-contribution fee of \$50 or \$25 concession is payable for this qualification.

Each student will undertake an LLN assessment on enrolment. Your training plan will then be individually tailored to meet your needs and additional support provided accordingly if required.

### USER CHOICE FUNDING

Traineeships are funded by the Queensland Government under the User Choice Skills Assure supplier 2021–22 policy. User Choice provides a public funding contribution towards the cost of training and assessment services for eligible Queensland Apprentices and Trainees

#### ELIGIBILITY

You must already have an employer willing to take you on as a trainee to enrol in this programme. Talk to your employer about choosing First Choice College as your Supervising Registered Training Organisation (SRTO) or give us a call on (07) 5689 5060 and we would be happy to talk to your employer.

#### COST

Eligible trainees that meet the Queensland state funding requirements will be charged a set fee per nominal hour. These fees are calculated at a regulated rate of \$1.60 per nominal hour. Nominal hours will vary depending on the qualification and the electives chosen. An individual training plan will be created for Trainees that details nominal hours and associated fees.

Concession rates of 40% (\$0.64 per nominal hour) apply for students who hold a current Health Care Card or who identify as Aboriginal or Torres Strait Islander. For eligible school-based trainees, the training is fee-free.

Non-funded apprentices and trainees will be charged a fee for service cost. This will be confirmed prior to the commencement of training. Information regarding costs will be outlined on the agreed training plan, which will be provided to the employer and trainee at time of induction.
